- 3. Reading of the September minutes was waived since each board member is furnished with a copy.
- 4. Financial Reports were reviewed.
- 5. Departmental Reports were given by Department Heads.
- 6. Mayor Anderson advised the Board that since Tony Terrell has retired, Clay has not had anyone to fill in so that he could take a day off. Carter Cook has agreed to enter TAUD Apprentice

- Program that Clay went through and become certified so that he can assist Clay and relieve him on occasion as needed.
- 7. Clay Wright, Water Wastewater Superintendent invited the Aldermen to visit the Water and Wastewater plant lagoon for a tour and explanation of how our system works. He advised that Wednesdays are the busiest testing days. All the Aldermen responded that they would like to schedule times to visit.
- 8. Alderman Shawn Francisco made a motion to approve the minutes, financial reports, and departmental reports. Motion was seconded by Alderman James Hines. Motion carried.
- 9. Codes Enforcement Jim Seaton advised the Board of a property on West Street owned by Brian Phillips is a candidate for condemnation should the Board chose to do so. If Board chose to follow through it would take approximately 4 months to complete the necessary steps. If at such time the Board chose to give the owner more time to resolve the problem they could do so. Mayor Anderson stated that he had hoped action would be taken by the owner before now at no added cost to the city. Mr. Seaton noted that any expenses incurred by the City will be added as a lien against the property.
